CARE AND MAINTENANCE

- 1. Decontaminate the suit according to on-site standard procedures.
- 2. Lay the garment on a large, illuminated surface.
- 3. Open the zipper and remove the gloves by pulling the glove inserts back through the sleeves.
- Inspect the entire garment for holes, tears or excessive chemical degradation. Repair or have Standard Safety Equipment Company repair any damage found. Replace the gloves if necessary.
- 5. Launder the garment by immersing it in warm water with detergent added.

*** Do Not Machine Wash ***

- 6. Hang the garment in a warm, dry, well-ventilated area until dry.
- 7. Inspect the garment thoroughly for holes or tears and re-lubricate the zipper.
- 8. Store the suit neatly folded with the zipper closed and the gloves and inserts removed.

No more than two lengths of hose may be used to attain a maximum final length of 100 feet.

DONNING

It is recommended that an assistant aid the person donning the suit.

- 1. Remove the garment from its packaging and inspect it thoroughly for damage and completeness.
- 2. Check that the gloves are securely installed and free from damage.
- 3. Connect the airline supply hose and adjust the air pressure to the maximum NIOSH permitted pressure for that hose length.
- 4. With the zipper open, place both arms in the sleeves and pull the suit over your head until it rests comfortably on the shoulders.
- 5. Adjust the airflow within the ranges specified on the approval label until a level is reached that is comfortable to the user.
- 6. Close the zipper by pulling along the direction of the closure. It is intended to be reasonably difficult. Do not force the zipper.
- 7. Fasten the waist belt in front. Adjust the belt until it is comfortably snug.
- 8. Wrap the belt attachment at the rear of the unit around the trailing air hose and snap in place.

DOFFING

It is recommended that an assistant aid the person doffing the suit.

- 1. Perform any needed decontamination before removing the suit.
- 2. Unfasten the belt by applying pressure simultaneously to the exposed flanges and pulling apart.
- 3. Open the zipper by pulling along the direction of the closure.
- 4. Pull the suit up off of the head and remove arms from the sleeves.
- Turn off the air supply and disconnect the external airline.
